President's Message

Thanks to all 40 of you who gave up a Saturday morning to attend our January Program Planning meeting. We accomplished what we came to do. We concurred with the LWVCA program recommendations of Expanding the Electorate; Election Reform; Money in Politics; and Redistricting under the umbrella of the LWVUS Making Democracy Work program. After sharing what we accomplished this past year, Donna Roper (Voter Service) led a brainstorming session on how to expand and/or improve on our local efforts. In general, members wanted to focus more on voter education and ways to get out the vote. The full list will be discussed at future Voter Service and Outreach committee meetings.

We also concurred with Census 2020 as a statewide Issue for Emphasis. We were fortunate to have Jim Masters, a League member with extensive knowledge and experience with the Census process, give us an overview of the counting method and the challenges and importance of getting a complete count. LWVCA will be supporting state and local government funding for census counts and educating the public on the importance of an accurate count. Locally, we will reach out to our region's Complete Count Committee to offer help with education efforts.

Following an update by Gene Zingarelli (Advocacy) on LWVCA legislative accomplishments over the previous two years, members selected Climate Change and Criminal Justice as Issues for Emphasis for 2019-2021. Gene's committee currently has members monitoring both of these issues and they see opportunities to carry out LWVCA education and advocacy at the local level.

After a comprehensive report from Debbie McKay (Advocacy) on our actions over the past year on affordable housing, homelessness and mental health, she recommended that those issues continue to be monitored going forward. Members will focus local resources on Climate Change and Criminal Justice for the next year.

To accomplish any of this, we need you, our members. Any one thing you can do will help us make a difference.

Housing & Mental Health Update

Housing and Mental Health Were Topics at January's Planning Session

At the January Program Planning meeting League members voted to continue to monitor housing, which includes homelessness, and health, which includes mental health at our local level. Monitoring is one of the roles of our Advocacy Committee, which will continue to follow these issues. Please contact Advocacy Committee Chair, Gene Zingarelli, and let him know if you would like to join the Advocacy Committee or help monitor these issues.

Periodically we will provide updates on these issues in The Voter. This month we take a look at mental health.

Homelessness and mental health are related issues. In the 2017 Sonoma County point-in-time homeless count, of those who were counted, **57% of the adults self-reported that they have a serious mental illness, including 21% who experience post-traumatic stress disorder (PTSD), and 30% who experience chronic depression. Thirty-one percent self-reported having substance abuse disorders.** Until these issues are adequately addressed it is highly unlikely that we will solve the homelessness crisis in our communities.

Because the League has been following these issues, you may recall that at the Mar. 2018 Lunch with the League event our featured speaker was Barbie Robinson, the Director of So. Co. Public Health Services. In her presentation Ms. Robinson stated that with the Public Health budget deficit, her department cannot serve all those who need mental health services. She further stated that, when those without a home have untreated mental health issues, they are more likely to wind up incarcerated. In fact, the

jail has been so impacted by mental health issues, that they are building an in-house mental health unit. The result of this trend is that the jail has become the largest in-patient mental health provider for those with low or no income in Sonoma County.

Ms. Robinson went on to say that there is a great need for affordable housing with wrap-around supportive services including mental health services. If mental health issues are not addressed, often a person placed in housing will once again lose the housing due to untreated issues. The State of CA is implementing a new program called "No Place Like Home" to provide counties with funds to develop affordable housing with mental health service. The County of Sonoma is set to receive \$5 million in funding for this program. Ms. Robinson's entire presentation is available as a YouTube video on the League's website.

There are several hopeful new developments--

At the 1/24/19 Los Cien luncheon on Health Care Access for Latinos several local agencies had good news to report. Todd Salinas, CEO of St. Josephs Health, said his organization gives 10% of their income (after expenses) to improve the community and they are donating \$1 million towards developing a psych health facility in Sonoma County to serve those without health coverage and who are low income. They hope to convert an existing long-term care facility into an inpatient MH facility. In addition, St. Joseph's is donating \$300,000 per year for a crisis stabilization unit with 13 beds. They also have a team of health professional who visit all the shelters to provide health assessments and referrals. However, only about 800 of those without a home are in shelters. St. Josephs is looking at how they may reach the rest of the homeless population.

Gabrilla Bernal, CEO of Santa Rosa Community Health, stated that their organization provides mental health services to those with low income with same day appointments. They just received funding to do care coordination for those leaving

incarceration, including MH services. The program has not yet started, but should have a positive impact. Lupe Navarro of Latino Service providers reported that their organization just

received a 5 year grant to work with the Latino community on MH services. Kaiser has also funded a program to work with the Latino community to reduce the stigma of seeking help.

HR1 is the first democracy reform agenda bill introduced in the House of Representatives in the 116th Congress. The League of Women Voters has long advocated for expanding voter registration. We were a leader in crafting the National Voter Registration Act of 1993 and have been at the table working with lawmakers to craft this new bill.

League Forum: March Special Election on The Future of Palm Drive's Hospital

We are at a crossroads for the small Sebastopol hospital the community has treasured for nearly 20 years. On March 5, voters in the Palm Drive Health Care District will vote yes or no on a proposal to sell the hospital to a private, for-profit company, ending its years as a public, non-profit hospital that serves all who come through its doors.

To help voters prepare, the League is holding a forum on February 8, 6:30-8 pm at the Sebastopol Community Church, 1000 Gravenstein Hwy North. Proponents and opponents will respond to questions. Since its purchase in 1999 from Columbia/HCA, the hospital has provided excellent, compassionate and friendly care to patients, in a way that only a small hospital can. Those whom it has served praise the hospital to the skies.

But the healthcare landscape is savage and the financial picture is grim. The District, which owns the hospital, is now \$28 million in debt and in its second bankruptcy. In spite of good intentions, hard work, and multiple managers, the hospital has consistently lost money. A majority on the District Board of Directors is urging the sale, arguing it is the best chance for the community to keep its hospital open – albeit a different kind of hospital. A minority of District Board members say the majority is so focused on keeping any kind of hospital open that it is willing to take far less than the property is worth.

This forum is of particular interest to voters in the communities of: Sebastopol, Graton, Bodega Bay, Carmet, Salmon Creek, Occidental, and Freestone. These voters will be deciding the question in the special election of March 5, 2019.

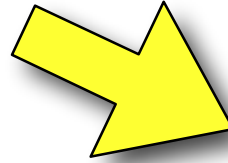
